From the Principal's Desk



Since its inception D.A.V. Centenary College has spared no effort to establish and maintain high standards of all-round excellence and impart values espoused and cherished by the D.A.V. movement so that our students go out into the world as confident, awakened, morally sound and well-rounded beings armed with sufficient general as well as specialized knowledge not only to successfully make their way through the maze of today's

complex and rather formidable world but also to work for the larger good of society and humanity. The college has never lagged behind in innovating with and moulding traditional courses so that our young men and women face no problem in successfully and painlessly adapting themselves to the rapidly changing socioeconomic and technological environment in today's globalised world. That the pursuit of serious, diversified and multidimensional academic activity which is at the same time job-oriented and in sync with the times is always on the top of our agenda is further borne out by the fact that , apart from traditional UG and PG Courses like B.Sc., B.Com., B.Com. (Hons), B.A., M.A. (English), M.Sc.(Computer Science) & M.Com., the college is running a string of a professional courses like BBA, BBA(CAM), BCA and Bachelor of Tourism & Travel Management and vocational courses like B.Com.(CA), B.Com.(TPP), B.A.(Marketing)and B.A.(Journalism and Mass Communication). And seven years ago we started Add On Courses like Computer Graphics, Animation Multimedia and Web Designing, Oracle 9: DBA and Computer Hardware Networking and Ethical Hacking. Last year the college started Certificate Courses in Tally and Microsoft Excel Training in collabration with INNOVENZA. And from this year the college is starting 12 more Certificate Courses and 2 Diploma Courses in partnership with NIIT Limited with a view to further strenghtening the Vocational Stream in the college. The college also has a state-of-the-art Language Lab so that our students can acquire greater linguistic skills. And this earnest quest of ours has translated into our students' consistently good showing in the university examinations through the years. Academic activity, being on the top of our agenda, includes serious classroom teaching round the year, extension lectures, talks, workshops, seminars and conferences including State Level Events

and National and International Conferences, Seminars and Conclaves. For instance, during the last six years the college has hosted four International and five National Conferences/Seminars with NAAC sponsored Nataional Seminar on Teaching and Learning Evaluation organised by the P.G. Department of Commerce and the College Internal Quality Assurance Cell held during the Session 2017-18. In the just-concluded session, the Department of Sanskrit organized a National Conference and the Department of Hindi a National Seminar. Also, with its focus on research, the college is at the moment publishing four refereed research journals. At the same time, with a view to promoting sound and creative thinking and writing skills among our students and the faculty, the college is now bringing out two magazines apart from the college magazine 'Shatabdi Pratigya'. But along with academics, sports and other extracurricular activities are our strong points and have always been vigorously promoted for the wholesome growth of our wards with consistently excellent results even at the National and International Level. Improving the overall ambience of the institution and providing the best possible facilities is high on our agenda. To this end, the Library Complex and the Computer Labs have been upgraded, revamped and expanded at considerable cost and the process is still on. In the same vein, smart classes have been set up and more such classes are in the process of being set up to minimize the chalk and talk method. A much needed two storey new building block came up a few years ago at a cost of Rs.3.5 crore to add to the already impressive and sprawling college buildings. It consists of 32 well-appointed classrooms, state-of-the-art computer labs with the latest software and hardware and a big sound -proof and airconditioned hall in the basement with a high quality sound system and acoustics which is now being extensively used for college activities and function as well as for big ticket event like International Film Festivals and Theatre Festivals. There are departmental libraries and a wellequipped Health Centre with a full time Medical Officer. An impressive Yajna Shala is there where regular Havan Yajnas are performed and discourses given for the spiritual uplift of the students and the faculty. The spiritual quotient of the students and the faculty is further taken care of by organizing discourses by spiritually elevated souls, spiritual courses as well as discussion and bhajan sessions even on Sundays and other holidays. The aesthetically landscaped and painstakingly maintained and manicured lawns, with hundreds of potted plants and trees dotting the campus and a riot of colour in the form of thousand of flowers, further enrich its ambience. All steps have been taken to augment water supply and provide adequate power back-up. The college website is now very much operational so as to make all the important information related to the college available to the students and their parents/guardians at the click of a mouse. Also the system of online admission and online payment of fee is very much in place. At the same time all possible steps are taken to maintain discipline in the campus. To further improve the overall security environment, CCTV cameras have been installed at strategic places in the campus and constant vigil is maintained to prevent any untoward incident. The persistent focus of the college on overall quality maintenance and improvement was rewarded with the Peer Team from NAAC accrediting our institution with 'A' Grade in November, 2015. Since I took over a little more than thirteen years ago, I have made an earnest attempt to impart a new dynamism to the all-round growth of the college and am committed to carrying forward this process so that this institution becomes a role model in the university and the region. My efforts, in tandem with the good work put in by our competent and dedicated staff, are already showing excellent results. And we are determined to continue the good work.

- Various Senior Faculty members of our college were invited as Resource Persons and Chaired Technical Sessions of several National and International Conferences and Seminars during the year.
- The Department of Hindi, under the aegis of the Uttar Pradesh Bhasha Sansthan, Lucknow, organized a National Seminar on 'Bhartiya Lok Sahitya ki Adhunik Yug Mein Prasangikta' in February, 2019, in which as many as 40 research papers were presented.
- The Department of Hindi also organized a Hasya Kavi Sammelan in March, 2019, in which 7 eminent poets from different parts of the country regaled the audience by reciting their poems.
- The Department of Sanskrit also organized a National Conference on 'Vartman Paripeksh Mein Vedic Vigyan' in January this year which was sponsored by Haryana Sanskrit Academy, Panchkula. The conference was attended by a large number of teachers and students and as many as 10 research papers were presented.
- Earlier in September, the Department of Sanskrit, at the direction of the office of the DHE,

- Our brilliant EMA students did the College proud by winning the Overall Trophy and 7
 Prizes including 6 First Prizes in the National Youth Festival organized by the Central
 University, Mahendergarh.
- The College won the 1st Prize in Photography and the 3rd Prize in One Act Play and Mehndi respectively in the North Zone Inter-University Youth Festival during the Year.
- In the All India Inter-University Youth Festival hosted by Chandigarh University, Mohali, during the year, the college won the 1st Prize in Mehndi, the 2nd Prize in Photography and the 4th Prize in One Act Play. The college had the distinction of winning prizes in all the three events in which it represented M.D. University, Rohtak.
- The College Sports also went from strength to strength with 8 of our students participating
 in International Tournaments and Championships and winning as many as 1 Gold, 2 Silver
 and 2 Bronze Medals in the Asian Championships in sports like Roll Ball, Yoga and Roller
 Skating.
- As for National Championships and Tournaments, our students won as many as 30 medals including 10 Gold in diverse sports and games like Cricket, Badminton, Kick-Boxing, Wushu and Taekwondo.
- In the State Level Tournaments and Championships, our students bagged 100 Gold, 60
 Silver and more than 20 Bronze Medals in different sports, making the college proud of their excellent performance.
- The college has lifted as many as 26 Inter-Zonal Sports Championships of the University this year including in Badminton, Roll Ball, Grapelling, Kick Boxing, Karate, Taekwondo, Cricket, Wushu, Kabaddi, Lawn Tennis and Soft Tennis.
- As for NCC Boys' Wing, 1 cadet attended the RD Camp and took part in the Republic Day March Past at Rajpath, Delhi. He was honored for this feat by His Excellency the Governor of Haryana with a Cash Prize of Rs. 11,000/- and got another Cash Prize of Rs. 5,000/from 1 Haryana Naval Unit. He has also been selected to take part in the Youth Exchange Programme and will be going to Russia for the purpose in June.
- A Cadet was adjudged the Best Cadet and won Gold Medal in DNT Camp-II held at Ropar,
 Punjab.
- Another Cadet won Silver Medal in the Service Subject in the above Camp. Still 2 other

Cadets Won Bronze in the Firing Competition in the same Camp.

- A Cadet won Gold in Seamanship in the All India Nau Sainik Camp held at Ropar, Punjab.
- A Cadet won Gold for being declared the Best Cadet in the ATC Camp held at Sohna, Haryana. Our College Unit won Gold both in Volleyball and Drill in the same Camp.
- The College Unit won Silver in the District Level Independence Day Parade Competition.
- The College Unit orgainzed a Maha Rally of 400 Cadets on 'Beti Bachao, Beti Padao' during the session.
- As for the NCC Girls' Wing, 2 of our Cadets not only attended the All India Nausainik Camp at Karwar in Karnataka but also won Gold in Seamanship Exam and Silver in Service Subject Exam respectively in the same Camp.
- 3 Cadets of the Girls' Unit attended the National Integration Camp at Amritsar, Punjab.
- 11 Cadets from the Girls' Unit attended the Directorate Naval Training Camp-II, 3 Cadets the Training Camp-III and 1 Cadet the Training Camp -IV, all orgainzed by the Chandigarh Directorate at Ropar.
- The College NSS Boys' and Girls' Units celebrated Swachhta Pakhwara in the month of August during which the NSS Volunteers visited schools, hospitals and community centres to spread awareness about cleanliness in general. They themselves undertook the cleaning work at these places, took out rallies and delivered lectures on the all-important issue.
- The NSS Units celebrated the Surgical Strike Day on 29th September, 2018. A Seminar and Poster Making and Essay Writing Competitions were organized to mark the day.
- The College NSS Units organized a Seven Day Camp and 2 One Day Camps in the college. 





ADMISSION RULES

- 1. Candidates seeking admission must fulfil the eligibility conditions of that particular class.

 The college will not be responsible if the admission of any student is not confirmed by M.D. University, Rohtak. The M.D. University rules regarding admissions will be applicable to students and if any change is made by the university at any stage in the said rules, it will be binding on the students. All admission are provisional, subject to approval by M.D. University, Rohtak. THE PRINCIPAL RESERVES THE RIGHT NOT TO GRANT ADMISSION TO ANY STUDENT WITHOUT ASSIGNING ANY REASON IN THE INTEREST OF THE DISCIPLINE OF THE COLLEGE.
- 2. The SC Candidates of Haryana shall be granted reduction/relaxation of 5% marks in the eligibility conditions in all the courses in the marks required for general category. The said reduction will be calculated as per the example given below:

As per Govt. Instructions, in a course where a general candidate requires to have 50% marks by giving 5% relaxation the minimum eligibility marks for a SC/ST candidate should be calculated as under:-

Out of 100 Marks needs to less=5

Out of 1 Marks needs to less=5/100

Out of 50 Marks needs to less=5/100×50=2.50

This way, minimum less mark where general category candidates are required to have 50% in a prescribed qualification, the total required marks for a reserved candidate will be 50-2.50=47.50 and not 45.

3. Students from the Board of School Education, Haryana, or other Boards and Universities recognized by M.D. University can be admitted to the class for which they are eligible under rules if they satisfy the conditions laid down by the University regarding their eligibility and admission.

4. THE FOLLOWING CATEGORIES OF STUDENTS ARE NOT TO BE ADMITTED:

- (i) Candidates, who have been placed under compartment in the Class XII Examination of the Board of School Education, Haryana, or any other Board or any other examination recognised by the university as equivalent thereto, in the 1st year of any undergraduate or postgraduate degree programme.
- (ii) Candidates who have failed in a university examination are not to be readmitted.

 Such candidates may reappear in the examination as ex-students.
- (iii) Candidates who have been detained or absented themselves from the University Examinations for two years in the same class.
- (iv) Students who have an inexcusable break in their studies.
- (v) Students who indulged in undesirable activities/gross misconduct during the previous

session in any other college or in this college.

5. Students from other Boards/Universities seeking admission to this college will have to produce at the time of interview original certificates of all the examinations passed prior to the class which they intend to join, original Inter-University/ Board Migration Certificate, Character Certificate and School/ College Leaving Certificate from the Principal of the institution last attended and the Detailed Marks Card/ Certificate of the qualifying examination. However, if they are admitted provisionally in the absence of any of the above documents, they will have to deposit all the original certificates along with two sets of the photocopies thereof with the college office latest by 10th August, failing which they will themselves be responsible for the consequences including the possible cancellation of their admission

In case a candidate is not able to submit the migration certificate when his registration is sent to the university, the migration of such candidates will subsequently be forwarded in original to the Registration and Scholarship Branch of the University as per the schedule and the late fee mentioned below.

All UG / PG Courses

- i) Upto 30th November With late fee of Rs. 500/-
- ii) Upto 31st January With late fee of Rs. 1000/-
- iii) Upto 31st March With late fee of Rs. 2000/-

NOTE:

- (a) The University Roll Numbers will not be given to the students unless they are registered with M.D. University through the college office.
- (b) The students are advised to keep with themselves a photocopy of any documents submitted to the college office at the time of admission or later during the year.

6. RULES FOR CANDIDATES PLACED IN COMPARTMENT

The candidates admitted to undergraduate self-finance / vocational / professional courses and postgraduate self-finance courses will be allowed compartment and the chances for clearing compartment as per the relevant university rules.

7. PROMOTION UNDER SEMESTER SYSTEM

Common Clause for all courses

- (i) The candidate will be allowed to appear in the examination if he/she meets the following requirements:
 - a. bears a good character

- b. has been on the rolls of department during the semester/year.
- c. has attended not less than 65% of Lectures delivered in theory as well as practical.
- (ii) The students studying in different semesters will be promoted to the next higher semesters as per the rules laid down by the university.

8. RE-ADMISSION IN CASE THE NAME IS STRUCK OFF BECAUSE OF CONTINUOUS ABSENCE FROM COLLEGE WITHOUT ANY INFORMATION

The name of the students remaining absent for 15 consecutive days after the start or during the academic session without any notice shall be struck off from the rolls of the Institute. A fine of Rs. 5/- per lecture/day shall be charged on account of remaining absent from the classes.

However, re-admission may be allowed on payment of Rs. 1000/- alongwith the required fine within 15 days with the permission of the Vice-Chancellor. If a student fails to report within this time limit, the seat will be declared vacant to be filled according to the university rules. Re-admission may be allowed by the Vice- Chancellor only once on the recommendation of the Principal on payment of the prescribed re-admission fee.

9. INSTRUCTIONS REGARDING UNIVERSITY EXAMS

The students are directed to consult the University Website for all information related to their university examinations and not depend solely upon the college to provide such information to them. As directed by the University, It is their responsibility to get all such information themselves from the MD University website www.mdurohtak.com.

10. INSTRUCTIONS FOR S.C. / B.C. CANDIDATES

All the Scheduled Caste / Backward Class candidates seeking admission to any class are directed to submit a certificate / an affidavit in respect of income as well as another certificate by way of proof of caste / class at the time of admission. The college is duty-bound to take such certificates from the candidates belonging to the above categories, in keeping with the commitment to this effect given by it to the Office of the Director General, Higher Education, Haryana.

11. RESERVATION OF SEATS AND WEIGHTAGES

Reservation of seats, in view of Reservation Policy issued by Govt. of Haryana vide Notification No. 22/10/2013-IGSIII dated 28.2.2013 and instructions received from time to time in various programmes offered in Govt./Govt. aided educational/technical/professional institution is as detailed below:

(b-1) Haryana Open General Category(HOGC)	50% of the State Quota i.e. 42.5% of total intake

Scheduled Caste (SC)	20% of State Quota (17% of total intake)
Backward Classes of Haryana (A)(BCA)	16% of State Quota (13.6% of total intake)
Backward Classes of Haryana (B)(BCB)	11% of State Quota (9.35% of total intake)
Physically Handicapped (PH)	3% of State quota (2.55% of total intake).

Note: The reservation of seats is as per Reservation Policy of the State Govt. of Haryana and is subject to change/amendment made by the State Govt. from time to time.

In the event of quota reserved for Physically Handicapped remain unutilized due to non availability for suitable category of handicapped candidates, it may be offered to Ex- Servicemen and their wards (1% and the dependant of Freedom Fighter 1%). Further, 3% reservation is also provided to Ex-serviceman/ Freedom Fighter and their dependants by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned year wise rotational system will be adopted. For example if Block-A of Backward Classes are given seats in academic year 2013, the next Block i.e. (B) Block of Category of Backward Classes will be given seats in the next academic year 2014 and so on.

Note: A roster register for reservation of seats for ex-servicemen/freedom fighter shall be maintained and carry forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided in the Prospectus (Chief Secretary to Govt. Haryana letter No. 23/27/2004-2GS-III dated 05.12.2008).

2. Guidelines for Reservation

- I. A candidate who applies for a reserved category or for both reserved and general categories will be considered first in general category. In case, he is not selected in general category, he/she will be considered for reserve category. The Scheduled Castes/Backward Classes candidates who get selected /admitted in Educational/Professional/Technical Institutions and Universities in open competition on the basis of their own merit, will not be counted against the quota reserved for scheduled caste/ backward classes, rather they will be treated as open competition candidates. However, such candidates shall fulfill condition of eligibility regarding age etc. as are meant for general category candidates (Memo No.13864-75 dated 24.8.2012 received from the Principal Secretary to Govt. of Haryana, Welfare of Scheduled Caste and Backward Classes, Department, Chandigarh).
- II. Benefit of reservation will be given to all the reserved categories upto 3rd counselling according to the

reservation policy given in the Information Brochure. In case at the time of 3rd counselling the reserved seats of various categories remain vacant and no eligible candidates of the reserved categories are available, these vacant seats may be thrown open to Haryana General Category. In case, the seats in Haryana General Category remain vacant at the end the same will be thrown open to All India Open Category

- III. If any seat remains vacant in sub-categories of BC(A) and BC(B), the same will be filled up through the candidates belonging to other category. For example, if any seat in BC(B) category remains vacant, the same will be filled up from BC(A) category and vice-versa.
- IV. A candidate having a minimum of 40% permanent disability will be considered physically handicapped for admission to a course, provided that the candidate is otherwise medically fit for the particular course. Such candidate will be admitted to the relevant courses on the basis of academic merit and not on the basis of degree of handicapped. Certificate should be as per Appendix-'A'.

Note: Criteria for benefit of reservation to Ex-Serviceman is available in appendix 'E'

One seat in each PG Course (except the courses in which the admissions are made on centralized basis at Central/State level) in the College/Institute where the strength is upto 30 and 2 seats where the strength is more than 30 have been earmarked for outstanding sports person(s) over and above the sanctioned intake. The eligibility criteria will be as under:-

I. The candidates should fulfil the minimum eligibility conditions prescribed in the Admission Brochure/Ordinances.

II. Cat.A-I:

i. The Candidates should have won 1st / 2nd /3rd position in Olympic Games, World Championship, World Cup, World University Games, Davis Cup, Wimbledon Championship, U.S. French and Australian Open Tennis Championship, Thomas Cup, Uber Cup, All England Badminton Tournament.

ii. Participation in the above mentioned tournament.

Cat A.-II:

- i. 1st /2nd/3rd position in Champions Trophy, Common wealth Games, Common Wealth Championships, Asian Games, Asian Champion ships, Asian Cup, World University Championship, Cricket Test Matches, One Day International Cricket Matches, International Athletic Permit Meet and SAF Games.
- ii. Participation in the above mentioned in A-II point.

Cat B.-

- i. 1st /2nd / 3rd position in AIIU tournaments/ National Games/ National Championships/ Federation Cup organized by National Sports Federations recognized by the Govt. of India.
- ii. Participation in the above mentioned in B-category

Cat C.-

- I. 1st/2nd /3rd position in zonal Inter- University tournaments/ zonal national tournaments/ representation in Inter University Tournament(s).
- II. The eligibility rules for the admission against sports seat, only those games which are recognized and adopted by the Inter University Sports Board of India/MDUSC and approved by AIU will be considered for determining admission against sports seats. List of games approved by AIU is appended at 'F'.
- III. The candidates should be eligible for Inter University Tournaments during the year of admission.
- IV. There should be continuity of participation of the applicant at various levels including Inter-Varsity Tournaments and his/her performance should not be more than one year old.
- V. The candidate better in sports will be admitted as per merit decided by the Committee at college level. It should be formed by the principal and merit for admission against sport quota seats should be decided at college level.
- VI. The candidate better in sports will be admitted as per merit decided by the Admission Committee of the concerned Department/ College. However, the Director Sports will approve the merit list prepare by the Admission Committee with regard to checking the genuineness of the certificates/merit.
- VII. In case of tie in sports merit, the candidate better in academic merit be given preference.
- VIII. (Mentioned point No. XI in received documents) The age of the student should not exceed 25 years.
- IX. The sports certificate and photograph of the player must be attested by the Secretary of the concerned federation.
- X. The candidate must possess the gradation certificate (other than University Tournaments) from the Sports Dept. of his/her state, on the basis of his/her representation/position at

- National/Inter-National /Zonal/State level tournament in the games recognized by AIU from time to time.
- XI. In case, there is no availability of Coach in the University, for the game in which the student is seeking admission, then University will higher the services of the Coach from Sports Department of Haryana.
- XII. Only those games which are recognized and adopted by the Inter-University Sports Board of India and approved by AIU will be considered for determining admission against sports seat.
- XIII. It will be mandatory for the admitted students to participate in the Sports activities of his/ her Department/University and should have consistently participated in Sports activities.

NOTE:

The application form received for outstanding sports quota seat up to last date of applying for admission shall be sent to the Director Sports within three days after the 3rd counselling of the concerned Department, if required any clarification/guidance. Thereafter, the Admission Committee will decide the case for admission within 10 days after the 3rd counselling. No late fee shall be charged from such candidates.

Conditions for admission against sports seats (UG Courses):-

One seat in each course (over and above the sanctioned intake) where the sanctioned intake is 30 seats and two seats where the sanctioned intake is more than 30 be earmarked in B.A/B.Sc./B.Voc./B.Com. and all other UG Courses (excluding Technical Professional Courses) subject to the following conditions:-

- I. The Candidates should fulfill the minimum eligibility conditions prescribed in the Admission Brochure/Ordinances.
- II. I/II/III position/participation at the School National Tournaments.
- III. I/II/III position/participation at the School National Games and Sports.
- IV. I/II/III position holder at the State level Tournaments.
- V. The candidate better in sports will be admitted as per, merit decided by the Committee of on the College level should be formed by the concerned Principal of the College and merit for admission against Sports Quota Seats should be decided at the College level.
- VI. In case of tie in sports merit, the candidate better in academic merit must be given preference.
- VII. The age of the student should not exceed to 23 years.
- VIII. It will be mandatory for the admitted students to participate in the sports activities of his/her Department/College/ Institution and should have consistently participated in the sports activities.

5. Admissions for Kashmiri Migrants

Two additional seats in each course offered in the Colleges Institutes (except the courses being run under the norms of BCI and NCTE and the admissions are made on centralized basis at state level) shall be earmarked for Kashmiri Migrants. Admission against these seats shall be made on the basis of merit of qualifying examination. Candidates are required to apply to the concerned College/Institute by the date notified in the schedule of admissions.

- 6. Admissions against Supernumerary Cultural Activities Seats One supernumerary seat in each College/Institute will be earmarked to promote cultural activities subject to the fulfilment of the following conditions:
- I. Any position in the National Youth Festival organized by the Association of Indian Universities, New Delhi.
- II. First position holder in the North Zone Inter University Youth Festival organized by the Association of Indian Universities.
- III. The age of the student should not exceed 23 years.
- IV. It will be mandatory for the admitted students to participate in the cultural activities of his/ her College/Institute and should have consistently participated in the youth festivals.
- V. The maximum age limit to participate in the Youth Festival of MDU and Association of Indian Universities is 25 years. So when a student takes the admission in any College/Institute with an age of 23 years can participate for next two years as per rules.

12. FOREIGN STUDENTS

The admission of foreign students to the college will be governed by M. D. University rules.

13. RULES FOR WITHDRAWAL

Withdrawal from the college after getting admission will be allowed by the Principal on receipt of an application to that effect from the student concerned, duly endorsed by his father or guardian. A student who applies to the Principal for leaving the college during the session will have to pay the fee and other dues for the whole session. Refund of fee, if any, will be as per M.D. University rules. No student will be permitted to leave the college until he/she has cleared all dues.

14. LIBRARY

The college has a very well-stocked, well-furnished and fully computerised Central Library Complex with an impressive numbers of reference books and OPAC and INFLIBNET facility. The Library subscribes to a good number of journals, magazines and newspapers. It has a well-stocked Book Bank as well.

Note: The students of the Final Year of any UG / PG Degree Program, who do not return the library books issued against their names till 30th June of the academic session, will be charged fine after the expiry of that period. And if they do not return the books even by 31st Oct. of the next session, their college security will be forfeited against the cost of the books.

15. IDENTITY-CUM-LIBRARY CARD

A student who is admitted to the college gets his/her Identity-cum-Library Card within 7-10 days of depositing the fee. The card is issued from the Library and cannot be used by any other person. It is mandatory for a student to keep his/her Identity Card with him/her on the campus and produce it on demand by a staff member. In case the card is lost, the Librarian should be immediately informed about it. In such a case, a student will get a new Identity Card only on production of a copy of the FIR registered with the police and payment of Rs. 100/-

ENVIRONMENTAL STUDIES PAPER

The subject of Environmental Studies has been included as a qualifying paper by the University in all Under Graduate Courses (including Vocational and Professional Courses) and the students will be required to qualify the same, otherwise the final result will not be declared and degree will not be awarded. The examination in respect of the above paper, except in case of the BBA General Course, will be conducted by the college. As for the BBA General Course, the examination in respect of the above paper will be conducted by the university in Sem-III under the nomenclature 'Workshop on Environment Studies.

ADD ON COURSES

The students of BA and B.Com. can also opt for job-oriented Add On Courses, namely Computer Graphics, Animation Multimedia and Web Designing, Oracle 9: DBA and Computer Hardware Networking and Ethical Hacking along with their regular Degree Programme by paying an additional fee of Rs. 6,000/- per annum at the time of admission. Upon successful completion of the first year of an Add On Course, they will get a certificate from M.D. University, Rohtak. Upon completion of the second year, they will be awarded a diploma and upon completion of the third year, they will be awarded a degree. However, an Add On Course will be run only if the minimum number of students opting for it is atleast 30.

OTHER VALUE ADDED VOCATIONAL COURSES

With a view to equipping our students well for the job market/self-employment, the college is also running Certificate Courses in Tally with Advanced Excel and GST respectively in collaboration with Cyberoism. The above courses are open to the students of all the UG and PG Degree Courses running in the college.

To further strengthen the vocational stream, the college, in partnership with NIIT Limited, is starting with effect from this session (2019-2020) two Diploma Courses in Applied Finance and Accounts and Computer Applications respectively. Both the Diploma Courses will be spread over six semesters, each semester ending with a certification.

The curriculum of the Diploma in Applied Finance and Accounts is approved by the National Skill Development Council (NSDC) and the Sector Skill Council, i.e., BFSI. It meets all the six National Occupational Standards (NOS) of the Accounts Executive Qualification Pack (QP).

The six Certificate Courses in Applied Finance and Accounts stream, starting from the 1st Semester and ending with the 6th Semester, will be as follows:

- 1. Certification in Personal Computing and Digital Life-style
- 2. Certificate in Advance Business Analysis Tools and Techniques for Management
- 3. Certificate in Computerized Financial Accounting Using Tally ERP-9, Level 1
- 4. Certificate in Computerized Financial Accounting Using Tally ERP-9, Level 2
- 5. Certificate in Corporate Finance and Management Accounting for Management
- 6. Certificate in Capstone Project Using Tally ERP-9 with GST and TDS

Upon the successful completion of the above 6 Certificate Courses, a student will be awarded a Diploma in Applied Finance and Accounts.

The Diploma in Computer Applications is approved by both NSDC and NASSCOM. It also meets all the six National Occupational Standards (NOS) of the Junior Software Developer Qualification Pack (QP).

The 6 Certificate Courses in the Computer Applications stream, starting from the 1st Semester and

ending with the 6th Semester, will be as follows:

- 1. Certificate in Computer Overview and Programming Structure and Methodology.
- 2. Certificate in Working with MS Office 2013.
- 3. Certificate in Logic Building and Effective Problem Solving
- 4. Certificate in Information Systems and Common Business Processes
- 5. Certificate in JAVA 7
- 6. Certificate in Professional Skills

Upon the successful completion of the above 6 Certificate Courses, a student will be awarded a Diploma in Computer Applications. Both the above Diploma Courses come with Placement Assistance after the completion of the Programmes

It will be compulsory for every student taking admission in the 1st Year of any UG Course in the college this year to opt for any of the above vocational courses.

However, the students opting for any of the ADD ON Courses already running in the college will be exempt from taking admission in the above Vocational Courses.

- XI. MASTER OF COMMERCE (M.Com.) (Two Year Degree Course)
- a) M.Com. (Previous) (Two Year Degree Course)

There will be two units of 40 seats each. Students who have passed B.Com. (Hons./ Pass) or B.B.A. or B.A. with Economics / Commerce/ Marketing/ Insurance as a subject or any other examination recognised by M. D. University, Rohtak, as equivalent thereto with 45% marks in aggregate are eligible to join M.Com. (Previous) comprising First and Second Semesters. The admission to this course will be made by the college itself on the basis of the merit of the qualifying examination.

Every student shall offer the papers as decided by the university, to be notified separately.

b) M.Com. (Final) (Two Year Degree Course)

Students who have passed the M.Com. (Previous) examination of M.D. University, Rohtak, or any other university recognized as equivalent thereto are eligible to join M.Com. (Final) comprising Third and Fourth Semesters.

XII. M.SC. COMPUTER SCIENCE (Two Year Degree Course)

a) M.Sc. Computer Science (Previous) (Two Year Degree Course)

There will be a unit of 40 seats. Students who have earned a Bachelor/ Post graduate degree in any discipline from M.D. University, Rohtak, or from any other university recognised as equivalent thereto with atleast 50% marks in aggregate are eligible to join the last year of M.Sc. Computer Science comprising First and Second Semesters. The admission to this course will be made by the college itself on the basis of the merit of the qualifying examination.

Every student shall offer the papers as decided by the university, to be notified separately.

b) M.Sc. Computer Science (Final) (Two Year Degree Course)

Students who have passed the M.Sc. Computer Science (Previous) examination of M. D. University, Rohtak, or of any other university recognised as equivalent thereto are eligible to join M.Sc. Computer Science (Final) comprising Third and Fourth Semesters.

Every student shall offer the papers as decided by the university, to be notified separately.

- Note:-1. A candidate who is placed under compartment in the qualifying examination shall not be allowed to join the M.Sc. Computer Science Course.

XIII. M.A. (ENGLISH) (Two Year Degree Course)

a) M.A. English (Previous) (Two Year Degree Course)

There will be a unit of 60 seats.

Eligibility: Bachelor's Degree / Shastri Examination (New Scheme) of three year duration or any other examination recognised by this University as equivalent thereto with atleast 45% marks in aggregate. The admission to this course will be made by the college itself on the basis of the merit of the qualifying examination.

b) M.A. English (Final) (Two Year Degree Course)

Students who have passed the M.A. English (Previous) examination of M. D. University, Rohtak, or of any other university recognised as equivalent thereto are eligible to join M.A. English (Final) comprising Third and Fourth Semesters.

Every student shall offer the papers as decided by the university, to be notified separately.

- Note: 1) A candidate who is placed under compartment in the qualifying examination shall not be allowed to join the M.A. English Course.
 - 2) For further details regarding the above course, the interested students are advised to contact the Coordinator, M.A. English Course, as per information given under the heading 'Assignments'.
 - 3) All the papers mentioned in respect of the various courses and classes / semesters thereof are subject to change by the university.

UNIVERSITY EXAMINATIONS, CLASS TESTS & ASSIGNMENTS

- a) Only such students will be permitted to appear in the University Examination as fulfil the conditions specified under Special Regulations for University Examinations.
- b) A student shall not be eligible to appear in the University Examination unless he/she has attended at least 65% of the full Course of lectures delivered to his/her class in each of the subjects and fulfilled his/ her eligibility pertaining to Class Tests and Assignments.
- c) Students using unfair means in the Class Tests/University Examinations shall be severely punished. All the concessions in fee etc. granted to such students shall be withdrawn. In serious cases the punishment may amount to heavy fine, expulsion from the college or rustication.
- d) Students who do not appear in a Class Test owing to any reason except that of illness shall be deemed to have secured zero marks in the paper(s) concerned and their fee concession will be withdrawn. In case of illness during the examination days, the students concerned will have to produce a medical certificate issued by an M.B.B.S. doctor.
- e) Student absenting themselves from Class Tests without leave shall be penalised as per the decision of the Examination Committee since it is compulsory for all the students to take Class Tests.

RELIGIOUS AND MORAL EDUCATION

In order to help our young scholars imbibe a code of ethical conduct and to acquaint them with our rich cultural heritage and religious tradition, the college lays special emphasis on religious and moral education. Havan Yajnas are held regularly and discourses by eminent scholars and men of religion and meditation sessions are arranged from time to time. All the students are advised to take special interest in these activities.

INTERNAL QUALITY ASSURANCE CELL

The College has a very active Internal Quality Assurance Cell with members, as per the requirement of the National Assessment and Accreditation Council, drawn from the college teaching and non-teaching faculty, students, alumni, management, academia, industry and from the field of social work. All the activities of the IQAC are geared towards the quality maintenance and quality improvement of the institution with the result that the college has been accredited with 'A' Grade by NAAC consequent upon the visit of its Peer Team to our institution in November, 2015, for its reassessment and reaccreditation.

N.C.C.

Apart from the N.C.C. Naval Wing Boys' Unit, the college has the proud distinction of having been allotted a Naval Wing Girls' Unit as well. Joining the NCC brightens career prospects by facilitating entry into the armed forces and also gives one an opportunity to safeguard the frontiers and the freedom of the country. Every years a Boy and a Girl are adjudged the Best NCC Cadets by the college and honoured at the Annual Prize Distribution Function.

N.S.S.

To inculcate a sense of social responsibility, promote social activism and inspire our students to live up to the motto "Service Before Self", the National Service Scheme Boys' Unit of the college is rendering yeoman's service. Every year a student is adjudged the Best N.S.S. Volunteer by the college and honoured at the Prize Distribution Function. With effect from the academic session 2014-15, the NSS Girls' Unit also came into being and has put up a fine example of national service during a short span.

SPORTS

For the wholesome growth and fine-tuning of their personality, students are exhorted to take active part in various games and field events. Talented and committed sportspersons are encouraged even to make a career out of sports. The College has in place a scheme of liberal scholarships and grants for promising sportspersons who have made a mark in sports. Students should please note that the matter of the grant of these scholarships and stipends and the quantum thereof will be decided by a duly constituted Sports Committee on the basis of carefully and rationally worked out criteria.

CO-CURRICULAR ACTIVITIES

Various Subject Societies, Associations, Clubs and Fora have carried out diverse extracurricular activities over the years, giving the students an excellent opportunity to hone their talent and genius and fine-tune their personality.

Upon getting admission, all the students shall become members of one Subject Society (from Sr. No.1 to 6) and one Association/Club/Society (from Sr. No. 7 to 18) as mentioned under the heading 'Assignments.'

It is compulsory for all girl students to become members of the Women's Cell. Only such students can apply for nomination to the office of a Society as have attended at least 65% lectures up to the date of application for such nomination.

Extramural activities of a high standard are the norm in our college. Our talented and committed EMA students are not only a force to reckon with in Zonal and Inter-Zonal Youth Festivals of the University but also regularly win accolades at the All India Inter-University Youth Festivals as well as at other State, National and even International Level Cultural Events.

MAGAZINES

The College brings out its in-house magazine *Shatabdi Pratigya* with a view to promoting the habit of good purposeful writing among students as well as a record of the goings-on and developments in the college during the year. PERSONALITY DEVELOPMENT PROGRAMME

The college is running a Personality Development Programme for the students of the college. A highly qualified and competent guest faculty has been involved in this programme so as to groom our students' overall personality and substantially improve their communication skills so that they can meet the challenges of the present day competitive world with confidence, elan and poise and succeed in their chosen fields. Plans are afoot to not only continue this extracurricular programme but also to strengthen it during the coming years.

CAREER COUNSELLING-CUM-PLACEMENT CELL

The college has in place a Career Counselling-cum-Placement Cell which effectively helps the students make the right career choices. The Cell also strives to ensure that the maximum number of students get good jobs and career openings upon passing out from the college.

WOMEN'S CELL

The Women's Cell set up under the auspices of the National Commission for Women and as per the directive of the Office of the Director General of Higher Education, Haryana, is very active. Over the years it has organised successful Legal Literacy Campaigns for college and school girls, State Level Workshops, seminars, discussions, debates, talks and inter-college declamation contests on women's issues and has a number of ambitious programmes lined up for the future.

LEGAL LITERACY CELL

STIPENDS & SCHOLARSHIPS

A number of charitable organisations like the R.K.M. Trust, Prerna Dham, Faridabad, and the Sita Ram Jindal Foundation, New Delhi, offer liberal assistance to deserving students in the form of stipends, subsidies and scholarships. The D.A.V. College Managing Committee, New Delhi, has instituted one Smt. Lajwanti Maharaj Singh Scholarship on a yearly basis which is awarded to a poor and deserving student of this college @ Rs. 200/- per month. Students, who secure any position between 1st and 15th in the Merit Lists of the University Semester Exams, will be given prizes at the Annual Prize Distribution Function. FINE FOR LATE PAYMENT OF FEE

If fee is not paid on the fixed dates notified by the college, an additional fine for late payment of the college fee will be charged at the rate of Rs. 25/- per day subject to a maximum fine of Rs. 250/-. After 10 days the name of the student concerned shall be struck off the college rolls. Clearance of arrears of Fee and payment of Readmission Fee will be required for readmission which will be given at the discretion of the Principal.

FEE CONCESSION, SCHOLARSHIPS & OTHER FINANCIAL ASSISTANCE

The college grants fee concession to financially hard-up but deserving students. Brilliant students are also given suitable incentives and concessions by the college. Applications for Merit and Merit-cum-Means Concessions will be invited in due course about which the students will be duly notified.

In the college there is provision for Students' Aid Fund from which money can be given to poor and deserving students for purchasing books, meeting their expenses on Tuition Fee and

University Fee and for other needs. Help can be rendered to poor students from the Red Cross Fund also.

Financial assistance is available for the students under the various schemes of the Govt. of India and the Govt. of Haryana like The Post Matric Scholarship Scheme of the Govt. of India (only for students belonging to Scheduled Castes/Backward Classes/Minorities) and the State Merit Scholarship Scheme of the Govt. of Haryana. Interested students should contact the college office for details regarding the above schemes, the prescribed application forms thereof and the last date for applying for the scholarship on offer.

QUARTERLY BUS PASS

- Applications for concessional Bus Passes will be entertained only in the months of July, October, January and April. Charges for a minimum of three months' period will have to be paid by the interested students by the 5th of the above months. The charges will be as per Haryana Roadways rules.
- 2. The students are required to return the Passes before leaving the college.

RAIL CONCESSION

Such concession is permissible only to outstation students for travelling to and from their hometowns during vacation period. The relevant address mentioned in the Admission Form will be the basis of consideration for the purpose. Daily commuters shall apply for railway concession within a week from the beginning of each term of the academic session.

NOTE: In case of loss of Bus/Rail Pass, an FIR will have to be lodged and a copy of the same submitted for getting a new Pass issued. In case renewal of a Pass is sought, the old Pass will have to be submitted and deposited for the purpose.

CYCLE / SCOOTER / BIKE PARKING FEE

Interested students will be charged the Cycle/Scooter/Bike Parking Fee for parking their vehicles in the Parking Stand inside the Campus for the entire session unless allowed otherwise in midsession. If any student parks his/her vehicle without locking it properly, the college will not be responsible for any resultant loss. .

BAN ON RAGGING IN EDUCATIONAL INSTITUTIONS

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately. The punishment may include expulsion/ suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding or withdrawing scholarships or fellowships and other benefits (ii) forfeiting campus placement opportunities or recommendations. (iii) debarring from appearing in any test or examination or other evaluation process (iv) debarring from representing the educational institution in any reasonal, national or international meet, tournament, youth festival, etc. (v) withholding results (vi) suspension or expulsion from hostel or mess (vii) cancellation of admission (viii) lodging of FIR with the local police. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent. Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or indisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear apprehension thereof in freshers or junior students or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame of embarrassment so as to adversely effect the physique or psyche of a fresher or a junior student or any type of abuse through electronic media or wrongful confinement, use of criminal force, assault as well as sexual offence, trespass, defamation or threat to defame will be deemed an act of ragging.

Hon"ble Supreme Court of India in SPL (C) No. 24295/2004 in the matter of University of Kerala V/s Council of Principals, Colleges of Kerala and others has ordered that if any

incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain to if his/ her explanation is not found satisfactory, the authority would expel him/her from the Institution.
