NOTIFICATION

It is notified for information of all concerned that keeping in view the extra ordinary situation arising out of the persistence demands of the students due to non-passing of their respective courses in admissible chances, the demand of the students for grant of special chance will be considered as per ordinance and subject to fulfilment of following conditions :-

1. The students who got registered/enrolled themselves for their particular course in the year 2001 onwards and have already availed/exhausted all their admissible chances as provided in the Ordinance(s) till the last exam i.e. May/ June 2024 shall only be eligible for this special chance. If anyone who is left with any admissible chance to pass the concerned programme/course shall not be eligible for this special chance.
2. The examination for special chance shall be held in offline mode only at the premises of University Campus.
3. The examination for this special chance may tentatively be conducted in the month of June/July 2024.
4. For this special chance, Exam wise/Course wise fee shall be chargeable as under:-

5. The examination forms along with fee shall be filled up through online mode as notified by the University. The students are advised that before submission of online examination form and fee, they must check/ensure their eligibility, and in case of any doubt, they must confirm it from the concerned Result Branch. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students desirous of availing this chance are advised to read the following conditions/instructions carefully:-
- i) The schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of result.
 - ii) The special chance is admissible to complete the Degree (course) for such students who have re-appear in one or more papers (subjects) and also for improvement of division, who could not improve division within their admissible chances. However, improvement is not permissible for B.Ed. course.
 - iii) The special chance will also be admissible for the students of PG Programmes for improvement of their marks from less than 55% to 55 % or above.
 - iv) The examination form panel for the special chance may be made live from 15.05.2024 to 05.06.2024.
6. As per Academic Council Resolution No.56 dated 10.09.2021, the Standing Committee constituted by the Vice-Chancellor may consider requests for granting special chance on case to case basis, irrespective of year of registration also in a program/course and may recommend the cases to the Vice-Chancellor for approval.

The candidates enrolled/registered prior to 2001 and recommended for special chance by the Standing Committee shall be allowed subject to the following :-

- i) The scheme and syllabi of examination will remain the same as that was applicable in 2001.
- ii) All such students under the special chance shall appear for exam at their own risk subject to the availability of nomenclature matching with the prescribed syllabus in 2001. If any dispute remains there in this behalf, the committee will decide this after the examinations, if required.
- iii) All such candidates shall not claim for nomenclature/syllabus according to their registration year and to this effect, they will also be required, to submit an undertaking at the time of filling exam forms.
